Over the past several years, the importance of antitrust regulation in Kazakhstan has largely increased. This is both due to the development of market relations inside Kazakhstan, and to the creation of the Eurasian Economic Union, integration processes and Kazakhstan's accession to the WTO. The legislation on competition protection and counteraction to monopolistic activities has been seriously amended and continues to develop and improve. AEQUITAS lawyers are perfectly familiar with the legislation and the lawapplication and judicial practice and can address most complex aspects of the national and supra-national antitrust legislation application.

AEQUITAS has signed cooperation agreements with experts extensively experienced in the economic-andanalytical and applied scientific research in the field of competition policy. # most representative projects

Documentary due diligence of Coca-Cola Almaty Bottlers operations as to their antimonopoly compliance. In the framework of the project, AEQUITAS lawyers reviewed the company's model commercial contracts and internal documentation governing its operations and conducted interviews with its executives and other employees.

Representation of a large listed Chinese investor acquiring the controlling stake at TNG Holding LLP, sole participant of a subsoil user company holding the subsoil use right under a contract for the production of raw hydrocarbons at the Tenge field in Mangystau Oblast. Matter included advice on competition regulations In Kazakhstan in terms of economic concentration and other aspects

Preparation of an independent legal opinion pursuant to Freshfields Bruckhaus Deringer LLP's assignment covering the Kazakh law issues regulating the activities of Kedentransservice JSC, a leading logistics terminal operator in Kazakhstan, for submission to the Dutch court in connection with the consideration of claim from the minority shareholders of TransContainer PJSC (Russian major container operator) against TransContainer PJSC and a number of other transportation companies. AEQUITAS's opinion contained comments on intricate issues of the local antitrust legislation, corporate legislation and tariff regulation related to transportation services.

Representation of Calouste Gulbenkian Foundation, a Portugal-based company, in its sale of 100% share in its subsidiary Partex Holding B.V. to a Thai state corporation PTTEP. At the moment of the sale, Partex held 20% participatory interest in the production sharing agreement on the Dunga oil and gas field. Matter included advice on competition regulations in Kazakhstan, participation in preparation of the application for economic concentration, advice on other issues connected to the transaction.

Advice to Johnson & Johnson on antitrust regulation matters, including with a view to a possibility to keep track of market product resale prices.

All-round legal support of the project intended to optimize the Kazakhstan-located business of a group of companies privately holding a FMCG logistics and distribution business (tobacco products, beer and soft drinks, grocery products, contraceptives, energy drinks, etc.). The project involved acquisition and transfer of a part of business of the existing Kazakh legal entities to one existing company to become the principal distributor in Kazakhstan. The project's especial complexity was in the obtainment of the authorized antimonopoly agency's consent to the transaction due to its intricate structure, since the Kazakh legislation does not fully regulate the issues of partial business acquisition. The project took almost 2 years to complete.

Support of the client in issues of Kazakhstan legislation, including civil law, corporate law, currency control law, antimonopoly law, amendment of the transactional documents and participation in the negotiations between the parties regarding purchase of indirect control over Tenge oilfield.

Transaction support in Kazakhstan of of Apergy Corporation and ChampionX Holding Inc., including consultations on every aspect of Kazakhstan legislation. Inter alia preparation of the antitrust application in order to obtain consent for economical concentration, support of the process connected to receipt of the consent for economic concentration. Review of all the transactional documents.

Notification to the antimonopoly agency of the Republic of Kazakhstan of the performed economic concentration based on participation of one and the same individuals in the executive bodies of several companies, performed for major foreign manufacturers of agricultural equipment.

Legal support of a transaction, including obtainment of antimonopoly agency's consent to economic concentration, in connection with acquisition of indirect control over a Kazakh bitumen producer by Gazprom Neft OJSC, a major Russian oil company.

All-round legal support of a transaction, including obtainment of antimonopoly agency's consent to economic concentration, in connection with the acquisition of indirect control over local companies by Xinjiang Guanghui Petroleum Co., Ltd., one of China's largest companies active on the global hydrocarbons market.

(an Indian company leading in drilling and seismic services) acquiring control over a Kazakh seismic prospecting company servicing subsoil users in the Caspian region.


