INFORMATION LETTER regarding amendments to the legislation of the Republic of Kazakhstan on mandatory pension contributions

Starting 1 January 2014, Kazakhstan introduced an additional category of employer's mandatory payments for its employees – mandatory occupational pension contributions (hereinafter, the Contributions).

According to Article 26 of the revised Law on Pension Provision¹, Contributions are payable by employers from their own funds in favor of employees whose occupations are provided for by the special List of Professions² and in case the employee labor conditions are confirmed as harmful (especially harmful) via production facilities attestation with respect to labor conditions (hereinafter, the Attestation).

The Contributions are accrued in the amount of 5% of employee's monthly income, which is taken for pension contributions calculation in accordance with the procedure established by the RK Government³.

The Contributions are to be transferred on a monthly basis before the 25th day of the month following the month of income payment⁴.

Employers are exempted from paying Contributions in respect of certain categories of employees (including persons reaching retirement age; disabled persons of the first and second groups in case the disability is established on a termless basis; and some other persons) and in cases where the Attestation has identified no harmful (especially harmful) labor conditions.

Please note that additional subordinate regulatory acts to govern the Contributions payment issues⁵ are expected to be adopted. No law-application practice with respect to the issues under consideration has been formed yet.
